Lt. Governor indicated that the subgroup tasked with selecting final candidates for the Executive Director position has narrowed the field to the two final candidates to be presented to the full board.

Chris Pieper provided an overview of the parameters for discussion within a closed meeting context. Character and the professional competence of respective candidates could be discussed; however, all other topics were prohibited to protect the professional reputation of the candidates. Additionally, compensation was not permitted to be directly addressed.

Commissioner Buhler asked about how funding would be allocated to the compensate the incoming Executive Director

Chief of Staff Kirsten Rappleye indicated staff had been in conversation with members of legislative committees, and details were in flux, but underway.

The Board agreed to enter a closed session to interview final candidates.

Lt. Governor Cox indicated he (and likely many of the legislators on the Board) have a working relationship with the other final candidate, Alan Matheson, considering his role as the Executive Director of the Department of Environmental Quality.

The Board approved the formalization of an offer for Alan Matheson to serve as the Executive Director for the Point of the Mountain State Land Authority Board

Jim Russell suggested that, if Alan declined the offer, Muriel be granted an offer to serve as the Executive Director

Commissioner Buhler indicated he would be stepping down from the Board of Regents (effective June 30th, 2019) and this would likely be his final meeting serving for the State Land Authority Board
